

Health Institute to provide comprehensive, local care and tailored treatment plans for each patient with an advanced team including gastroenterological surgeons and specialists.





SHARING THE GIFT OF A MOTHER'S LOVE

Joanna Johnson gives back through a Charitable Remainder Trust

Joanna Johnson, a longtime Mission Viejo real estate broker, knows firsthand the lifesaving difference that Providence Mission Hospital makes in our community because our doctors saved her mother's life.

It was Thanksgiving 2007 when she brought Florence C. Johnson to Providence Mission Hospital for emergency surgery for colon cancer. Her mother was 92 years old at the time.

Florence spent two weeks in the hospital, during which Joanna came to know our doctors and nurses well. She never forgot their kindness, or the way the hospital became her home away from home during those difficult days.

Happily, Florence recovered and went on to live 10 more years. The experience led Joanna to become a donor to Providence Mission Hospital Foundation. In a recent legacy planning newsletter, she learned about the advantages of a Charitable Remainder Trust (CRT), which can reduce tax liability while supporting a person's preferred charity.

An individual first donates an appreciated asset, such as stock or real estate, to the trust. The trust then disburses income to beneficiaries for life or a term of years, after which the remainder is donated to a qualifying charity like Providence Mission Hospital Foundation.

A CRT is a great way for investors to shield themselves from taxes while putting their estate to work for the



community. However, many are unaware of the option. Even Joanna - an experienced real estate broker was unfamiliar with it.

The pandemic had already led Joanna to begin planning her estate, and she immediately saw the benefits of a Charitable Remainder Trust.

"I decided that the next property to be sold, I would transfer to a Charitable Remainder Trust for Providence Mission Hospital Foundation," she says. "My donation is driven by my love for my mother and the lifesaving operation she was given at the hospital."

Joanna contacted Jim Frey, director of estate and gift planning, who guided her through the process. Joanna's trust was set up within weeks, and she says it couldn't have been easier. She had several questions about how the trust would operate. Everything was explained in detail, making her decision easier.

Having lost several family members to cancer, Joanna is directing her donation to the hospital's Leonard Cancer Institute.

"I'm happy to have my gift go to the cancer institute," she says. "Hospitals, doctors and nurses are under siege like never before, and they need all the support they can get."

GIFTS OF REAL ESTATE

If you own real estate, it is likely to be a substantial part of your personal wealth. When you donate real estate through a CRT, your property is sold without incurring immediate capital gains tax and gualifies for a partial tax deduction. Sale proceeds are invested to create lifetime income for you or others or for a specified period of up to 20 years. When the income benefits end, the remaining assets become available to the hospital.

The combination of avoiding capital gains and enjoying a tax deduction makes a gift of real estate a strategic way to meet charitable goals. TAX-FREE **GIFT FROM YOUR IRA**

If you are $70\frac{1}{2}$ or over, a transfer directly from your IRA is a simple yet highly effective way to give:

- The amount transferred counts toward your required minimum distribution if one is due.
- You pay no income tax on the amount transferred.
- Transfers up to \$100,000 (annual aggregate amount) qualify for this favorable tax treatment each year.

\$35 million launch goal reached for Orange County's advanced multidisciplinary cancer center

Providence Mission Hospital Foundation has achieved its \$35 million launch goal for the Judi and Bill Leonard Institute for Cancer Prevention, Treatment and Wellness. The philanthropic partnership between Providence Mission Hospital and its community has brought world-class cancer care to south Orange County.

The four-story, 104,000-square-foot cancer facility located directly across Medical Center Road from Providence Mission Hospital's Mission Viejo campus was financed largely through generous gifts from our community, including a transformational eight-figure gift from long-standing supporters Judi and Bill Leonard, for whom the institute is named. "This institute represents an immense opportunity for our community to bring world-class cancer care to all the residents of south Orange County," Bill Leonard shared.

Since its 2019 opening, the Leonard Cancer Institute is actively meeting the demand for a full range of cancer services – driven by the latest scientific, genetic and surgical advancements – customizing care for each patient's needs.

FUNDRAISING UPDATE

Patients have access to cancer services and seamless care within a single building. The first floor houses the Quandt Serenity Chapel, the Valiant Spa featuring wellness products and services, the Swenson Family Interventional Radiology Center and the Sabatasso Family Healing Garden.

The second floor includes the Walter A. Craig Center for Palliative Care, the Phillips Family Diagnostic Imaging Center, physical therapy, Naydene's Kitchen for dietary and nutritional instruction and the Pellini Family Conference Center where multidisciplinary tumor board meetings take place.

The third floor is home to the offices of OC Surgeons as well as the Digestive Health Institute, which includes physician offices and endoscopy center. The fourth floor houses the offices of Hematology & Oncology, as well as a therapeutically designed infusion center that provides patients with mountain views and a full range of private, semi-private or communal treatment settings.

"The patient was at the center of every decision the hospital made in designing the institute," says John Miller, chief philanthropy officer for Providence Mission Hospital Foundation. "While the initial fundraising goal has been reached, we will continue to support our patients and their care providers for as long as the fight against cancer endures."
